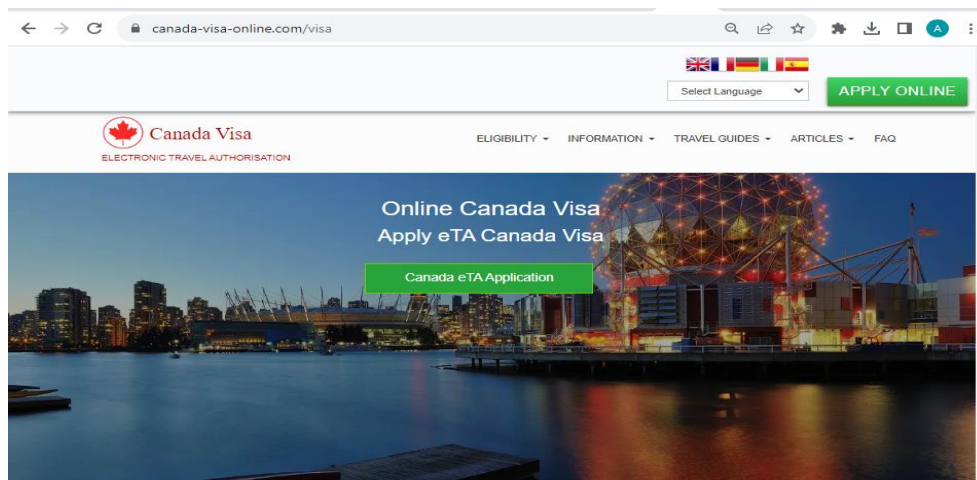


FOR BRITISH AND WELSH CITIZENS - CANADA Government of Canada Electronic Travel Authority - Canada ETA - Online Canada Visa - Cais Visa Llywodraeth Canada, Canolfan Ymgeisio am Fisa Canada Ar-lein.

Beth yw Visa Ar-lein electronig Canada neu ETA neu Awdurdod Teithio Electronig. Mae Awdurdod Teithio Electronig ETA yn rhagofyniad mynediad ar gyfer y dinasyddion hynny NAD oes angen Visa stamp papur arnynt mewn geiriau eraill gwladolion gweinydd fisa sy'n mynd i Ganada trwy Airplanance. Mae Awdurdod Teithio Electronig wedi'i gysylltu'n electronig â'ch Pasbort. Mae'n fisa tymor byr ar gyfer Canada. Mae'n ddilys am gyfnod o bum mlynedd neu hyd nes y daw eich Pasbort i ben, pa un bynnag sydd gyntaf.



Os caiff eich pasbort ei golli, ei ddwyn neu ei ddifrodi neu ei adnewyddu, yna mae angen i chi wneud cais am Fisa Canada Ar-lein arall neu ETA. Gyda Fisa Canada Ar-lein dilys neu Awdurdod Teithio Electronig, gallwch hedfan allan i Ganada sawl gwaith am arosiadau byr (fel arfer cyhyd â 180 diwrnod neu chwe mis fesul ymweliad). [Canada Visa Application Online](#) Ar y pwynt pan fyddwch chi'n ymddangos ar ffin Maes Awyr, bydd swyddog yn gofyn am weld eich copi E-bost o Canada ETA neu Visa Canada Ar-lein a hefyd yn gwirio'ch pasbort. Beth i ddod i'r maes awyr pan fyddwch chi'n cael Visa Canada Ar-lein Cymeradwy, cadwch yr e-bost copi meddal neu'r allbrint wrth law.

Rhaid i'ch pasbort gyd-fynd â chi Visa Canada Ar-lein neu Awdurdod Teithio Electronig, bydd yn gysylltiedig â'r fisa roeddech chi'n arfer gwneud cais amdano. Bydd gweithwyr y cwmni hedfan yn adolygu eich fisa neu ETA i gadarnhau bod gennych Awdurdod Teithio Electronig Canada cyfreithlon. Sicrhewch eich bod yn cario'r pasbort gwreiddiol, os oes gennych chi basbortau lluosog, yna cariwch y pasbort sy'n gysylltiedig â'ch ETA Canada neu Visa Canada Ar-lein. Cadwch draw o broblemau yn y derfynell awyr, Pan fydd eich Awdurdod Teithio Electronig wedi'i gymeradwyo a'i ardystio, gwnewch yn siŵr bod y rhif adnabod a grybwyllir ar gyfer eich e-bost cymeradwyo Awdurdod Teithio Electronig yn cyfateb i'r rhif yn eich Tudalen Pasbort.

Os na fyddant yn alinio ac yn cyfateb, rhaid i chi wneud cais eto am Awdurdod Teithio Electronig arall ar gyfer Canada neu Fisa Ar-lein Canada. Mae Dinasyddion a Phreswylwyr y gwledydd canlynol yn gymwys i wneud cais am Fisa Ar-lein Canada neu ETA, Gwlad Pwyl, Croatia, Prydain dramor, Sbaen, Norwy, y Swistir, Israel, Lithwania, Slofenia, Ynysoedd Cayman, Gwlad Belg, De Korea, Seland Newydd, Rwmania, Malta, Taiwan, Lwcsembwrg, Denmarc, Bahamas, Barbados, Samoa, Ffrainc, Hong Kong, Br. Virgin Is., Gwlad Groeg, yr Iseldiroedd, y Ffindir, Awstralia, Singapore, Papua Gini Newydd, yr Almaen, Awstria, Mecsico, Talaith Dinas y Fatican, y Deyrnas Unedig, Cyprus, Iwerddon, Chile, Gwlad yr Iâ, Latfia, Ynysoedd Solomon, Hwngari, Japan, Portiwgal, Montserrat, Slofacia, Sweden, Bwlgaria, San Marino, Liechtenstein, Brunei, Andorra, Monaco, Gweriniaeth Tsiec, Estonia,

yr Eidal ac Anguilla. What is a Canadian electronic Online Visa or ETA or Electronic Travel Authority. An Electronic Travel Authority ETA is a entry prerequisite for those citizens who do NOT require paper stamp Visa in other words visa waiver nationals going to Canada via Airplane. An Electronic Travel Authority is electronically connected to your Passport. It is a short term Visa for Canada. It is valid for period of five years or until your Passport expires, [Canada Visa Application](#) whichever is sooner. If your passport is lost, stolen or damaged or renewed, then you need to apply another Online Canada Visa or ETA. With a valid Online Canada Visa or Electronic Travel Authority, you can fly out to Canada multiple times for short stays (ordinarily for as long as a 180 days or six months per visit). At the point when you show up on the border of Airport, an official will request to see your Email copy of Canada ETA or Online Canada Visa and also check your passport. What to bring to the airport when you get Approved Online Canada Visa, keep the soft copy email or printout handy.

Your passport must match your Online Canada Visa or Electronic Travel Authority, it will be connected to the visa you used to apply. The airline employees will review your visa or ETA to confirm that you have a legitimate Canadian Electronic Travel Authority. Ensure that you carry the original passport, if you have multiple passports, then carry the passport that is connected to your Canadian ETA or Online Canada Visa. Keep away from problems at the air terminal, When your Electronic Travel Authority is approved and endorsed, make sure that the identification number mentioned for your Electronic Travel Authority approval email matches the number in your Passport Page. In the event that they don't align and match, you must again apply for another Electronic Travel Authority for Canada or Online Canada Visa. Citizens and Residents of the following countries are eligible to apply for Online Canadian Visa or ETA, Poland, Croatia, British overseas, Spain, Norway, Switzerland, Israel, Lithuania, Slovenia, Cayman Islands, Belgium, South Korea, New Zealand, Romania, Malta, Taiwan, Luxembourg, Denmark, Bahamas, Barbados, Samoa, France, Hong Kong, Br. Virgin Is., Greece, Netherlands, Finland, Australia, Singapore, Papua New Guinea, Germany, Austria, Mexico, Vatican City State, United Kingdom, Cyprus, Ireland, Chile, Iceland, Latvia, Solomon Islands, Hungary, Japan, Portugal, Montserrat, Slovakia, Sweden, Bulgaria, San Marino, Liechtenstein, Brunei, Andorra, Monaco, Czech Republic, Estonia, Italy and Anguilla.
