## National Interest Waiver (NIW)

Green Card Link has created proven winning techniques for NIW petitions, allowing us to ensure approval for the national interest waiver green card that we file. Physicians who agree to work in areas with a scarcity of health care providers for at least five years are eligible for a National Interest Waiver (NIW).

Recommendation letters are sometimes known as testimonial, reference, or support letters. These letters are required when applying for an EB-2 NIW (National Interest Waiver). Officers analyse provided documentation to establish eligibility for standard petitions or labour certification waivers, as they are typically not experts in the appropriate sector of work.

To qualify as a multinational manager or executive under this preference (EB1-C), the applicant must have worked for the same multinational firm or other business entity (parent, subsidiary, affiliate, or branch of the U.S. business) that employs the applicant in the United States for at least one year within the three years preceding the application. Furthermore, the petitioner must desire to continue working for the same firm as a manager or executive.
